PARTY INFORMATION AND GUIDELINES

In order to ensure a great party experience for all, we ask that you please be aware of the following party guidelines. Parties are booked on a first come, first served basis and full package payment is due at the time of reservation. Parties must be booked two weeks in advance.

GENERAL

Cake: The birthday cake is NOT included in the party fees. The only outside food that is permitted is birthday cake/cupcakes. (no ice cream permitted) Please bring your own candles, cake knife, lighter, utensils and extra for adults.

Paper products: We will provide private tables with paper products (cups, napkins and plates) for children only, and only for pizza.

Party Leaders: Will greet you, review the celebration plan, make food arrangements, set up, and clean up. Your party leader is not responsible for serving food or facilitating activities in the Aquatic Center.

Food: Two XL pizzas and two pitchers of pop included for package guests only. However additional food is available to order for other guests for a fee. Menu will be provided once party is booked.

Seating: You are provided a section of tables outside the park. There is no food/gift storage. All food/gifts must be removed from concessions at the end of your 1 hour party.

Admittance: You main gain entry into the Park anytime on date of party. Party area is available no earlier than the scheduled time.

What to Bring:

- Plates, napkins and cups for the adults.
- Cake plates for everyone.
- Forks, spoons, and knives for everyone.
- Cooler– THERE IS NO REFRIGERATION AT THE PARK
- Cake, candles, cake knife, server, and lighter

REFUND POLICY

Refunds will not be issued for parties canceled within 7 days of scheduled party. There is a \$60 cancellation fee, otherwise.

INCLEMENT WEATHER POLICY

No refunds are available due to inclement weather. Weather is unpredictable, and can pose certain health and safety hazards. Depending on the severity of the weather and availability, parties will be postponed. However, this is not guaranteed.

FACILITY USE AGREEMENT

Parties are subject to all policies, rules and regulations of the Aquatic Center.

The undersigned hereby verifies that they understand the following:

1. Children 6 years and under must be directly supervised in the water by an individual 16 or older who must be an arm's length away at all times.
2. Children over 6 years of age but under 10 must have an adult within the facility at all times.
3. Appropriate and approved swim wear is required. Males cannot swim in basketball shorts.
4. Swim diapers and rubber pants are required for children not yet potty trained. These are available for purchase at the concession stand.
5. For safety reasons flotation devices and toys are not allowed (with the exception of Coast Guard approved life jackets).
6. To ride the body & tube slides, you must be 42" tall and a swim test may also be required.
7. Outside food and drinks are not permitted into the facility. A concession area offers food and drinks for sale and an outdoor picnic area is available outside the facility.
8. No swim goggles are permitted while riding the slides.
9. Understand that TFAC is not open during inclement weather. Staff will contact the applicant to discuss the status of the event.
10. Alcohol is prohibited in Aquatic Center, parking lot or on adjacent properties.
11. Smoking is prohibited on Aquatic Center property.
12. One adult per child attending the party is included (any age). Any additional adults are \$7 to enter the facility. Additional passes can be bought at the TFAC front desk or can be added to the groups final bill.

This application is not valid until authorized by the city of Troy, and signed by patron below as acknowledgment and agreement to all the terms and conditions. Refunds will not be issued for parties canceled within a week of the party date. A \$60 service charge will be deducted from all refunds. All rules and adult/child ratios must be followed while using the building, including parents directly supervising children in the water. **Package payment is due in full within 2 business days of placing the reservation.**

Signature is an agreement that party must be paid in full in order for the party date to be reserved and booked and any additional fees must be paid within two business days after the party.
