Read below carefully before completing. The undersigned hereby verifies that they: Children 6 years and under must be directly supervised in the water by an individual 16 or older who must be an arm's length away at all times. 2. Children over 6 years of age but under 10 must have an adult within the facility at all times. 3. Appropriate and approved swim wear is required. Males cannot swim in basketball shorts. 4. Swim diapers and rubber pants are required for children not yet potty trained. These are available for purchase at the concession stand. 5. For safety reasons flotation devices and toys are not allowed in the facility (with the exception of Coast Guard approved life jackets). 6. To ride the body & tube slides you must be 42" tall and a swim test may also be required. 7. Outside food and drinks are not permitted into the facility; a concession area offers food and drinks for sale and an outdoor picnic area is available outside the facility. 8. No swim goggles are permitted while riding the slides. 9. Understand that TFAC is not open during inclement weather. Staff will contact the applicant to discuss the status of the event. 10. Deposits are only refundable if cancellation is made 15 days prior to event, inclement weather or extenuating 11. Alcohol is prohibited in Aquatic Center, parking lot or on adjacent properties.
