FACILITY USE AGREEMENT

Permits are subject to all policies, rules and regulations of the Aquatic Center. Read below carefully before completing. The undersigned hereby verifies that they:

- Children 6 years and under must be directly supervised in the water by an individual 16 or older who must be an arm's length away at all times.
- Children over 6 years of age but under 10 must have an adult within the facility at all times.
- Appropriate and approved swim wear is required. Males cannot swim in basketball shorts.
- Swim diapers and rubber pants are required for children not yet potty trained. These are available for purchase at the concession stand.
- For safety reasons flotation devices and toys are not allowed in the facility (with the exception of Coast Guard approved life jackets).
- To ride the body & tube slides you must be 42" tall and a swim test may also be required.
- Outside food and drinks are not permitted into the facility; a concession area offers food and drinks for sale and an outdoor picnic area is available outside the facility.
- No swim goggles are permitted while riding the slides.
- Understand that TFAC is not open during inclement weather. Staff will contact the applicant to discuss the status of the event.
- Deposits are only refundable if cancellation is made 15 days prior to event, inclement weather or extenuating circumstances.
- Alcohol is prohibited in Aquatic Center, parking lot or on adjacent properties.
- Smoking is prohibited on Aquatic Center property.
